NOTICE IS FURTHER GIVEN that official Nomination Petitions and Declarations of Candidacy for eligible candidates desiring to file for the above elective offices (except city council races in the cities of Colfax, Lincoln, Loomis, Rocklin and Roseville) may be obtained from the Placer County Elections Office, 2956 Richardson Drive, Auburn, CA 95603 beginning July 16, 2018, Monday through Friday from 8:00 AM to 5:00 PM, excluding holidays. For the Tahoe area, Nomination Petitions and Declarations of Candidacy may be picked up at the Customs House Building located at 775 North Lake Blvd., Tahoe City, Tuesday through Thursday from 11:00 AM to 3:30 PM beginning July 17, 2018, excluding holidays. Completed documentation shall be returned to the Placer County Elections Office or the Customs House Building for filing. Candidates for Colfax, Lincoln, Loomis, Rocklin and Roseville city offices must obtain their nomination paperwork from their respective City/Town Clerk. Contact the appropriate City Clerk's office for more information.

NOTICE IS FURTHER GIVEN that filing is open Monday, July 16, 2018 and will close Friday, August 10, 2018, after which time no candidate filing documentation will be accepted. If an incumbent does not file his or her declaration of candidacy on or before August 10, 2018, the period for all non-incumbents to obtain and return their candidate paperwork will extend to August 15, 2018. The Tahoe location for extended filing is

available Monday, August 13th – Wednesday, August 15th, 11:00 AM to 3:30 PM. Placer County Elections Office hours are 8:00 AM to 5:00 PM.

NOTICE IS FURTHER GIVEN that if there are not enough candidates to fill a district's open seats, there will be no election unless a petition requesting an election is submitted to the Elections Office by 5 p.m. Wednesday, August 15, or furthermore requested by the district. The petition must be signed by 10 percent of the district's voters or 50 voters, whichever is less. Instead of an election, the Board of Supervisors will appoint the candidates who have filed nomination papers. If any open seats remain, they will be filled by appointment as follows: for school districts, by the Governing Board of the School District; for special districts, by the Board of Supervisors. [Education Code sec. 5326; Elections Code sec. 10515]

NOTICE IS FURTHER GIVEN that consolidated with the General Election the following measure shall be put to a vote of the qualified voters in the City of Rocklin:

Measure A – City of Rocklin

To keep park and recreation facilities safe, clean and well maintained, shall the measure approving Rocklin City Ordinance 1093 be adopted? This measure would allow the City to continue to collect a \$10.00 to \$30.00 per year special tax to be used only for park maintenance and development. It would raise \$600,000 annually and would extend for 10 years through June 30, 2029.

NOTICE IS FURTHER GIVEN that consolidated with the General Election the following measure shall be put to a vote of the qualified voters in the City of Roseville:

Measure B – City of Roseville

Shall the measure to ensure essential City services including neighborhood police patrols, fire protection, 9-1-1 emergency response; crime suppression/investigation; street and pothole repair; libraries, parks and recreation; job creation and economic improvement programs; and unrestricted general revenue purposes by establishing a 1/2¢ Transaction and Use (“sales”) tax, providing an estimated \$18.4M annually, until ended by voters, with independent citizens’ oversight, regular audits, no money for the state, and all funds spent locally, be adopted?

NOTICE IS FURTHER GIVEN that consolidated with the General Election the following measure shall be put to a vote of the qualified voters in the City of Colfax:

Measure C – City of Colfax

To fund general municipal expenses such as police, fire, roads and recreation, shall the City tax cannabis (marijuana) businesses at annual rates not to exceed \$10.00 per canopy square foot for cultivation (adjustable for inflation), 6% of gross receipts for retail cannabis businesses, and 4% for all other cannabis businesses; which is expected to generate an estimated \$8,000 to \$12,000 annually and will be levied until repealed by the voters or the City Council?

NOTICE IS FURTHER GIVEN that consolidated with the General Election the following measures shall be put to a vote of the qualified voters in the Placer Union High School District:

Measure D – Placer Union High School District

\$2,341,000 raised annually until 2050, rates estimated at \$27 per \$100,000 assessed valuation be adopted, with independent oversight/audits, funding used for Del Oro High School only?

Measure G – Placer Union High School District

To repair/upgrade aging classrooms/labs/facilities at Placer High School; repair deteriorating roofs/plumbing/bathrooms; upgrade math/computer/engineering labs and vocational/career education classrooms; maintain safe drinking water; improve safety/security systems; shall the measure for Placer High School Facilities Improvement District No. 1 of Placer Union High School District issuing \$42,100,000 in bonds at legal interest rates, averaging \$2,447,000 raised annually until 2050, rates estimated at \$27 per \$100,000 assessed valuation be adopted, with independent oversight/audits, funding used for Placer High School only?

NOTICE IS FURTHER GIVEN that consolidated with the General Election the following measure shall be put to a vote of the qualified voters in the Tahoe Truckee Unified School District:

Measure AA – Tahoe Truckee Unified School District

Tahoe Truckee Unified School District Save Our Schools Renewal Measure. To ensure all students receive a well-rounded, high quality education to prepare them for college, university and careers; maintain and prevent cuts in science, technology, music, art, honors and career/job training programs, shall Tahoe Truckee Unified School District renew and increase its expiring parcel tax at the rate of \$148 generating \$5,600,000 annually for 9 years; requiring citizens oversight, independent audits, senior exemptions, and funds used in Tahoe Truckee Unified School District, be adopted?

NOTICE IS FURTHER GIVEN that direct arguments for or against said measure(s) shall be submitted to the Placer County Elections Office (except arguments for municipal measures). Said arguments shall not exceed 300 words in length and may be received or withdrawn, but not changed, prior to and including August 10, 2018 at 5:00 PM. The Placer County Registrar of Voters shall cause (if submitted) one argument for and/or one argument against said measure(s) to be printed and shall cause to be enclosed a copy thereof in each County Voter Information Guide. If multiple arguments are submitted either for or against a measure, the Placer County Registrar of Voters shall choose and print one argument in accordance with applicable law or procedure.

NOTICE IS FURTHER GIVEN that, for individuals interested in submitting arguments for or against said measure(s), the physical address for the Placer County Elections Office is 2956 Richardson Drive, Auburn. The mailing address for the Placer County Elections Office is PO Box 5278, Auburn, CA 95604.

NOTICE IS FURTHER GIVEN that when the Placer County Registrar of Voters has selected the direct arguments for and against said measure(s), the Placer County Registrar of Voters shall send copies of the argument in favor of said measure(s) to the authors of the argument against and copies of the argument against to the authors of the argument in favor. The authors may prepare and submit rebuttal arguments not to exceed 250 words. The rebuttal arguments must be filed with the Placer County Registrar of Voters not later than 10 days after the final date for filing direct arguments. The final date for rebuttal arguments is August 20, 2018 at 5:00 PM.

NOTICE IS FURTHER GIVEN that California Elections Code Section 9600 governs the form of said arguments and/or rebuttals. Arguments and/or rebuttals submitted to the Placer County Elections Office must follow this form. Authors of said arguments/rebuttals may call the Elections Office at 530-886-5650 for more information and a copy of this Elections Code Section.

NOTICE IS FURTHER GIVEN that the last day to register to vote for the General Election is October 22, 2018.

NOTICE IS FURTHER GIVEN that vote-by-mail ballots will begin to mail on October 8, 2018. (Date may be changed due to the Columbus Day holiday.) The last day for the Elections Office to mail a requested vote-by-mail ballot is October 30, 2018.

NOTICE IS FURTHER GIVEN that at the General Election the polls will be open from the hour of 7:00 AM to the hour of 8:00 PM on the day thereof.

NOTICE IS FURTHER GIVEN that after the polls are closed on the date of said election, the ballots will be transported to the central counting location at the Placer County Elections Office, 2956 Richardson Drive, Auburn, CA 95603.

NOTICE IS FURTHER GIVEN that the opening and processing of the vote-by-mail ballots for said election will take place at the Placer County Elections Office starting October 23, 2018 and continue through Election Night, November 6, 2018.

NOTICE IS FURTHER GIVEN that the canvass will commence on or before 8:00 AM on November 7, 2018 at the Placer County Elections Office.

NOTICE IS FURTHER GIVEN that the Elections Office will be open for business the two weekends prior to the General Election (October 27th and 28th and November 3rd and 4th from 9:00 AM to 4:00 PM.

NOTICE IS FURTHER GIVEN, in accordance with provisions of the election laws of the State of California, that on November 7, 2018 at 10:00 AM, the Placer County Elections Office will randomly select precincts for a manual tally of one percent (1%) of the precincts casting ballots at the November 6, 2018 General Election.

NOTICE IS FURTHER GIVEN that this random selection of precincts is open to the public.

NOTICE IS FURTHER GIVEN that on November 19, 2018 at 9:00 AM, the Placer County Elections Office will begin a manual tally of one percent (1%) of the precincts casting ballots at the November 6, 2018 General Election.

NOTICE IS FURTHER GIVEN that this manual tally is open to the public and shall continue daily (Saturdays, Sundays and holidays excluded unless otherwise decided by the County Registrar of Voters) until completed.
